PRE-QUALIFICATION AND BIDS FOR EMBEDDED SOLAR POWER SUPPLY FOR KADUNA STATE
GOVERNMENT HOUSE

The Kaduna State Government through the Kaduna State Power Supply Company intends to carry out installation and operation of *Rooftops Solar Photovoltaic (PV) Energy Systems* in the Kaduna State Government House.

The installation will help achieve the objective of providing a *Grid Tie Solar Photovoltaic Power Plant* infrastructure of not less than 2MWp capacity with a view to attaining highest feasible levels of clean energy.

Interested, qualified and reputable professionals are hereby invited to apply.

Scope of Work

The scope of the Embedded Solar Power Supply for Kaduna State Government House shall involve/ but not limited to the following:-

- I. Site Survey, technical feasibility, financing, regulatory & policy assessment;
- ii. Securing all planning permits and approvals, from local authorities as applicable;
- iii. Providing all necessary labour, material, services, tools, plant and equipment for the works;
- iv. Offer a range of viable project delivery options, including but not limited to:
 - a) Design, construct, operate, maintain, provide supply to the Government House under MOU for a contract duration;
 - b) Design, construct, operate, maintain, and provide grid tie solar power supply with a generator backup;
 - c) Power purchase contract.
- V. Any other (details to be provided).

Pre-Qualification Requirements

Bidders are to provide the company profile which shall include and MUST be arranged in this order:

- i. Registration certificate with Certificate of Incorporation (CAC)
- ii. Current registration with Kaduna State Public Procurement Authority (KADPPA Annex, former Tenders Board),
- iii. Current Business premises registration with Ministry of Commerce, Industry and Tourism.
- iv. Evidence of Tax clearance for the last 3 years (2015 — 2017).
- v. Auditors report for the last 3 years (2015-2017).
- vi. VAT Registration and Remittances.
- vii. Evidence of Current Registration of Business Premises with Kaduna State Ministry of Commerce, Industry and Tourism.
- viii. Evidence of Compliance with PENCOT
- ix. Evidence of Compliance with Industrial Trust Fund (ITF)
- x. List of professional staff with qualifications and registration with appropriate professional
- xi. Bodies including certification as electrical installation contractor by NEMSA.
- xii. Previous similar works executed at least three (3), with evidences of awards and completion and/or certificates of payments within the last Five (5) years.
- xiii. Any other document that may be necessary to pre-qualify the bidder.
- xiv. Each prequalification document must be paginated and duly signed by an authorized personnel.

Submission of Bids

The prequalification (Technical) and bid document (Financial) and other supporting documents should be fully paginated and sealed in 3 (Three) separate envelopes.

The original prequalification and 4copies should be put in the same envelope sealed and marked "Technical"; the original Financial Bid and 4 copies will also be put in another envelope sealed and marked "Financial".

Two of these envelopes shall be placed in a bigger outer envelope and be so marked including the address, telephone numbers of the company at the reverse side. A copy each of the Technical and Financial bid shall both be placed in a sealed third envelope and indicated at the top right side in addition to other information - "Control Copy", which shall be dropped in the Tender Control Box (TCB).
