- iv. Evidence of Tax clearance for the last 3 years (2016,2017,2018).
- v. Auditors report for the last 3 years (2016,2017,2018).
- vi. VAT Registration and Remittances.
- vii. Evidence of Current Registration of Business Premises with Kaduna State Ministry of Business, Innovation and Technology.
- vii. Evidence of Compliance with PENCOM.
- ix. Evidence of Compliance with Industrial Trust Fund (ITF).
- x. Previous similar works executed at least 3Nr. with evidences of awards and completion and/or certificates of payments within the last Five (5) years.
