In exercise of the powers conferred on me by Section 12 of the Grazing Law Cap. 62 Laws of Kaduna State 1991 and all other Laws enabling me in that behalf, I Nasir Ahmad el-Rufai, Governor of Kaduna State hereby make the following Order:

1. This Order may be cited as the Kagarko Grazing Reserve, Short title Order, 2018.
2. All that piece of land, the situation and limits whereof are set forth in the First Schedule hereto, shall constitute a Government Grazing Reserve within the meaning of the Law, which Reserve shall be known as Kagarko Grazing Reserve. Creation of Kagarko Grazing Reserve

FIRST SCHEDULE

All that piece of land measuring about 8,524 hectares at KAG_KAGARKO GRAZING RESERVE_001_A0 In Kaduna state, is now preserved, starting from point 1 which lies on latitude X= 350387 and longitude Y= 1055360 to point 72 which lies on latitude X= 353888 and longitude Y= 1049511 of Kagarko grazing reserve.

SECOND SCHEDULE

RIGHTS WITHIN THE RESERVE

1. Rights of Way

To the general public the right of way, all the footpaths joining neighbouring villages and settlements passing through the Reserve.

2. Other Rights

Subject to all restriction lawfully imposed by a competent Authority :-

- (i) The right to draw water.
- (ii) The right to take in quantities sufficient only for the personal domestic requirements of the right holders, but not for sale or barter and provided there is no interference with other vegetation e.g. tree felling and bush burning.
- (iii) The right to:
 - (a) fetch in reasonable amount of grass for thatching and fodder;
 - (b) dead wood for fuel;
 - (c) fruits from cultivated trees and plants such as Parkia Clappertonia (Dorowa), Vitex Doniana (Dinya), Prosopis Africana (Kirya), Butyros Premium Parki (Kadanya), Ximenia Americana (Tsada), Balanitis Egyptiaca (Aduwa), Ziziphus Mauritiana (Magarya), Annona Senegalensis Gwandan Daji); and
 - (d) the leaves of all plants for medicinal and consumption purposes in quantities not sufficient to destroy the plants.
