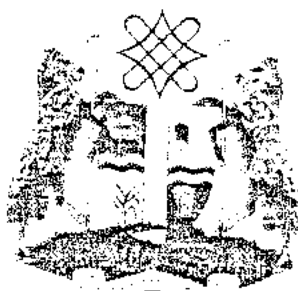


**A LAW TO MAKE PROVISION FOR FIRST SUPPLEMENTARY APPROPRIATION

BE IT ENACTED by the House of Assembly of Kaduna State as follows:

Enactment

1. This Law is cited as the First Supplementary Appropriation Law, 2018.

Short Title

2. This Law comes into operation on the 25th day of July 2018.

Commencement

3. The Accountant General of Kaduna State of Nigeria, may on the warrant of the Commissioner of Finance, Kaduna State issue from the Consolidated Revenue Fund of Kaduna State during the year ending the Thirty First day of December, 2018 any sums not exceeding in whole the sum of **Thirty Nine Billion, Six Hundred And Fifty Million Naira Only (₦39,650,000,000.00)** as specified in the Schedule herein.

4. The sum mentioned in Section 3 of this Law shall be appropriated for the purpose of and in the manner expressed in the Schedule.




