PROPOSED DEVELOPMENT OF STANDARD ZOO along the EASTERN BY-PASS, KADUNA INVITATION FOR EXPRESSION OF INTEREST

- 1.0 The Kaduna State Government, through the Ministry of Commerce, Industry and Tourism, called the Ministry, has decided to build a modern zoo along the Eastern By-pass, Kaduna, to boost tourism.
- 2.0 The Ministry invites interested, suitable and qualified:
- a) consultants and
- b) investors to express interest to participate in the design and development of a standard zoo to be situated along the Eastern by-pass of Kaduna on an area covering ten (10) hectares.

3.0 Scope of services

The scope of the services comprises:

a) Consultants:

- i. Development of design for a standard zoo with the entire envisaged facilities, based on guidelines to be provided by the Ministry
- ii. The proposed standard zoo design and envisaged facilities shall be vetted by the Ministry,
- iii. The design should be conducive to the interest and safety of Tourists;
- iv. It shall have recreational areas like parks and gardens, with park-friendly and family-oriented structures.
- v. There shall be wide-space animal enclosures, allowing free movement of different animal species for grazing and other daily activities, and Enclosures for animals that are out of the view of the public.
- vi. The design shall include free pathways for Tourists' movement, in-house veterinary clinic, administrative offices, stores for animal feeds and maintenance, and parking spaces for vehicles amongst others. The proposed design shall put into consideration local climate and geographical features to ensure animals can withstand severe weather and natural disasters.

b) Investors

- i. Provide financial model and
- ii. Revenue generation plan.

4.0 Expression of Interest Requirements

In compliance with the relevant provisions of the Kaduna State Public Procurement Law, the Ministry wishes to invite interested corporate bodies, firms and individuals to submit at least, but not restricted to, the following documents:

- i. Certificate of registration with the Corporate Affairs Commission (for corporate entities)
- ii. Form CAC2 (shareholders) and CAC7 (Particulars of Directors) of the company.
- iii. 3D drawing and presentation of the proposed modern zoo, showing the theme and activities to be developed in the area
- iv. Evidence of current Tax Clearance Certificates for 2014, 2015 and 2016.
- v. Evidence of Tax Identification Number (TIN)
- vi. Current Certificate of Registration with the Kaduna State Public Procurement Authority (former Tenders Board)
- vii. Current Registration of Business Premises with Kaduna State Ministry of Commerce, Industry and Tourism.
- viii. Evidence of Registration with FIRS, KADIRS, VAT and remittances.
- ix. Verifiable evidence of partnership in case of a consortium
- x. Comprehensive profile of the Applicant.
- xi. Audited Accounts of the Company (corporate) for 2014, 2015 and 2016.
- i. Name and address of at least three (3) previous Clients who could be contacted for references.
- ii. Verifiable evidence of financial capability
 - i. Any other information that would be relevant.

Expression of Interest documents shall be <u>arranged</u> in this particular order, <u>paginated</u> and <u>signed</u> on each page by an authorized representative of the company.
