- f) VAT registration and Evidence of Remittance.
- g) Evidence of compliance with PENCOM:
- h) Evidence of track records of handling and successful completion/in progress of similar projects accompanied with Award letters, Valuation, Practical completion Certificates, issued by client:
- i) Company profile with key Staff with evidence of their Qualifications, professional registration, CV, and experience.
- j) Equipment and Technology capacity with evidence of ownership/lease (where applicable).
- k) Verifiable evidence of financial capability and Banking support:

All of the above should be in the Profile of the Company and any other information that may technically qualify your company for the works.

They MUST be arranged in the order above, properly paginated and duly signed, by an authorized representative of the company.
