SCOPE OF WORK

The scope of the project to be carried out comprises the following:

- Desilting of Urban Drainage Network in Kaduna, Kafanchan and Zaria metropolis; PRE-QUALIFICATION REQUIREMENTS Interested firms should submit, among others, the following documents:

 - xii. Any other relevant information that would be helpful in determining the Firm's suitability for the works.
