COLLECTION OF BID DOCUMENTS

Interested Contractors/Firms should collect Bid Documents from the Office of the Director of Forestry of the Ministry of Agriculture and Forestry, Kaduna State after showing evidence of payment of the sum of N50,000.00 to the Kaduna State Government.

SUBMISSION/OPENING OF TENDER

The prequalification document (Technical bids), together with completed financial bid, with other supporting documents should be fully paginated and sealed in two (2) separate sealed envelopes appropriately marked "Technical" and "Financial" respectively.

Each envelope should be clearly marked on the right top corner with the project title, while the company name and address should be written at the back of the envelope. Both envelopes should be sealed in a bigger envelope marked with the appropriate project title and addressed to:
