### 1.0 INTRODUCTION/BACKROUND

Kaduna State Government is constructing three new additional rehabilitation centres and upgrading existing ones in the State to enable persons living with disability to acquire skills and become self-reliant.

The Kaduna State Rehabilitation Board on behalf of the Kaduna State Government hereby invites interested and eligible contractors to bid for construction works in some rehabilitation centres in the State.

#### 2.0 PRE-QUALIFICATION REQUIREMENTS

#### 1.1 Technical Bids

Interested reputable contractors should submit but not limited to the following:

- a. Certificate of registration/incorporation with the Corporate Affairs Commission (CAC)
- b. Evidence of current registration with the Kaduna State Public Procurement Authority.
- c. Company Audited Account for three years (2017-2019)
- d. Evidence of current Tax Clearance Certificates for three years -(2017-2019)
- e. Evidence of current registration of Business premises with Kaduna State Ministry of Business Innovation and Technology.
- f. Technical experience and qualifications of key personnel with evidence of registration with appropriate professional bodies.
- g. Evidence of similar verifiable project successfully executed/completed/on-going with attached copies of award letters, payment and completion certificates.
- h. Equipment and Technology capacity with evidence of ownership/lease agreement.
- i. Evidence of Financial capability and Banking Support.
- j. Evidence of VAT registration and remittances.
- k. Evidence of compliance with Industrial Training Funds (ITF).
- I. Evidence of compliance with PENCOM.
- m. Evidence of Bid Security (*If applicable*) in the form of Bank Guarantee or Certified Bank Draft from a reputable Bank in Nigeria.
- $n. \quad \text{Any other information that would be relevant.}$

The Documents shall be **arranged** in the order above, **paginated** and **signed** on each page by an authorized representative of the Bidder.

- a) Completed Technical and Financial Bids are to be submitted in three (3) hard copies each (Original, Duplicate and Control copies).
- b) The Technical and Financial bids must be inserted in separate sealed envelopment clearly marked "**Technical Bid**" and "**Financial bid**."
- c) All the envelops must bear the **name and contact number of Bidder** at the rear sides while the '**Project Description**' and '**Lot No**.' clearly marked at the top left-hand corner of the envelopes and address to:

- d) The **Original and Duplicate** copies of the Technical and Financial bids shall be placed in a large outer envelope which shall be dropped into the **<u>Bid Box</u>**.
- e) The **Control copies** of the Technical and Financial Bid documents shall be marked at the top right-hand side as '**Control Copy**', and dropped in the Control Box.
- f) Failure to comply with this requirement of separate and sealed envelopes for Technical and Financial Documents shall lead to disqualification.
- g) The submission shall be made not later than 12.00Hrs Nigerian time Tuesday, 7<sup>th</sup> April 2020.

## 4.0 OPENING OF BIDS

The Technical and Financial Bids document received **shall be opened immediately** after the close of receipt of bids in the presence of the representatives of the Bidders at the boardroom of:
