REQUEST FOR EXPRESSION OF INTEREST (EOI)

The 300-Bed Specialist Hospital, Millennium City, Kaduna is currently under construction and nearing completion. Upon completion, the hospital will help to achieve the expansion and improvement of the State's tertiary health care delivery. In order to ensure an effective and sustainable operation of the hospital and all its complementary facilities, the government has opted to wholly outsource the management and operation of the hospital.

The Kaduna State Government hereby requests for Expressions of Interest for the management and operation of the hospital from firms with the requisite competence, technical and financial capacity and verifiable track record of managing and operating hospitals of similar capacity.

The successful firm shall be responsible for the staffing and day-to-day operation of the hospital including an integrated facility management, human resource management as well as making any necessary investments to improve on the hospital's scope of health services in line with global best practice.

SUBMISSION/OPENING OF EXPRESSIONS OF INTEREST (EOI)

Expressions of Interests (EOIs) from hospital management specialist firms must clearly indicate the following:

- I. Full name, address and evidence of registration;
- II. Profile of company, including copies of all registration documents;
- III. Evidence of partnership in case of a consortium;
- IV. Evidence of track record of executing similar services;
- V. Evidence of Tax Clearance Certificate for 2013, 2014, 2015 from the Federal Inland Revenue Services (FIRS) from any of the members of the consortium
- VI. Submission Audited Accounts for 2013, 2014 and 2015
- VII. Evidence of Managerial, Professional and Technical Qualifications of Key Personnel of the firm or consortium;

Expressions of Interest must be submitted in six (6) copies (one original and five copies) in a sealed envelope clearly marked "EXPRESSION OF INTEREST FOR THE MANAGEMENT AND OPERATION OF THE 300-BED SPECIALIST HOSPITAL, MILLENNIUM CITY, KADUNA".
