Date of Commencement

BE IT ENACTED by the House of Assembly of Kaduna State as follows:

- This Law is cited as the Appropriation Law, 2019. 1.
- This Law comes into operation on the day of Commencement 2.
- 3. The Accountant General of Kaduna State of Nigeria, may on the warrant of the Commissioner of Finance, Kaduna State issue from the Consolidated Revenue Fund of Kaduna State during the year ending the Thirty First day of December, 2019 any sums not exceeding in whole the sum of One Hundred and Fifty Seven Billion, Four Hundred and Forty Nine Million, One Thousand, Eight Hundred and Sixty One Naira, Fifteen Kobo Only (#157,449,001,861.15) as specified in the schedule herein.
- The sum mentioned in Section 3 of this Law shall be 4. appropriated for the purpose of and in the manner expressed in the Schedule.
