Date of Commencement

**BE IT ENACTED** by the House of Assembly of Assembly of Kaduna State as follows:

Enactment

1. This Law is cited as the Second (Supplementary) Appropriation Law, 2016.

Short Title

2. This Law comes into operation on the .....30<sup>th</sup>..... day of .....December..... 2016.

Commencement

3. The Accountant-General of Kaduna State of Nigeria, may on the warrant of the Commissioner of Finance, Kaduna State issue from the Consolidated Revenue Fund of Kaduna State during the year ending Thirty First Day of December, 2016 any sums not exceeding in whole the sum of **Fifteen Billion Three Hundred and Two Million, Eight Hundred and Nineteen Thousand, Nine Hundred and Twenty Seven Naira, Eighty Two Kobo only (₦15,302,819,927.82)** as specified in the Schedule herein.

Expenditure of **₦15,302,819,927.82** only from the Consolidated Revenue Fund

4. The sum mentioned in Section 3 of this Law shall be appropriated for the purpose of and in the manner expressed in the Schedule.




