- iii. Evidence of Tax Clearance Certificate for 2014,2015 and 2016 ;
- iv. Current Certificate of registration with Kaduna State Public Procurement Agency (Tenders Board);
- v. Current Business Premises Registration with Kaduna State Ministry of Commerce, Industry and Tourism;
- vi. Company audited accounts for 2014, 2015, and 2016;
- vii. Evidence of VAT registration and remittances;
- viii. Letter of Banking or financial support;
- ix. Evidence of track record of similar projects successfully completed in the last three (3) years;
- x. Any other relevant information that would be helpful in determining the firm's suitability for the project.

Interested contractors/firms should collect bid documents from the Secretary, Resident Due Process Team, at the Ministry of Justice, Secretariat Complex, Kaduna; upon presentation of bank draft of requisite bidding fee, being non-refundable fees in favor of the Kaduna State Government for each lot.

be fully paginated and sealed in two(2) separate envelopes appropriately marked “Technical” and “Financial” respectively. Each envelope should be clearly marked on the top right corner, stating the project lot number and title, while company name and address should be written at the back of the envelope. Both envelopes should be sealed (as a set) in a bigger envelope marked with the appropriate
