### PRE-QUALIFICATION AND BIDS FOR EXTENSION OF ELECTRICITY SUPPLY TO MILLENNIUM CITY, KADUNA.

The Kaduna State Government through the Kaduna State Power Supply Company intends to provide the Extension of Electricity Supply to Millennium City with the objective of extending power supply to this prime part of the city in order to promote its functional development.

#### Scope of Work

The scope of work comprises the construction of about 16.5KM of 33KV Overhead line from the Old Power Station, Kakuri to Millennium City and Construction of 15MVA Substation with Outgoing 11KV Feeders to provide power to Distribution Transformers as outlined in the Bills of Quantities (BOQ).

#### **Pre-Qualification Requirements**

Bidders are to provide the company profile which shall include and MUST be arranged in this order:

- i. Registration certificate with Certificate of Incorporation (CAC)
- ii. Current registration with Kaduna State Public Procurement Authority (KADPPA Annex, former Tenders Board),
- iii. Current Business premises registration with Ministry of Commerce, Industry and Tourism.
- iv. Evidence of Tax clearance for the last 3 years (2015 2017).
- v. Auditors report for the last 3 years (2015-2017).
- vi. VAT registration and Remittances.
- vii. Evidence of Current Registration of Business Premises with Kaduna State Ministry of
- viii. Commerce, Industry and Tourism.
- ix. Evidence of Compliance with PENCOM
- x. Evidence of Compliance with Industrial Trust Fund (ITF)
- xi. List of professional staff with qualifications and registration with appropriate professional
- xii. Bodies including certification as Electrical Installation Contractor by NEMSA.
- xiii. Previous similar works executed at least three (3) with evidence of awards and completion and/or certificates of payments within the last Five (5) years.
- xiv. Any other document that may be necessary to pre-qualify the bidder.
- xv. Each prequalification document must be paginated and duly signed by an authorized personnel.
