**INVITATION TO BID FOR CONSTRUCTION, RENOVATION, PROCUREMENT AND INSTALLATION SERVICES**

**1.0. INTRODUCTION/BACKGROUND**

Barau Dikko Teaching Hospital is a tertiary teaching hospital owned by the Kaduna state government and serves primarily as the training and research facility for the College of Medicine, Kaduna state University, Kaduna. In order to reposition itself towards meeting the aspirations and yearnings upon which it was established, the hospital wishes to expand its emergency care services to patients, equip its ICU with modern equipment, upgrade its maternal health services, and construct a modern central sterile supply department (CSSD) among other services, in line with the international best standards. Therefore, in compliance with the provisions of the Kaduna State Public Procurement Law 2016, The Barau Dikko Teaching Hospital on behalf of the Kaduna State Government hereby invites interested, eligible and competent Contractors to bid for the following:

**2.0. SCOPE/DESCRIPTION OF PROJECT**

2.1 Construction of Outpatient Departments (Lot1):

This involves the construction of all outpatient departments in the former NITEL building, with the sole aim of improved service delivery.

2.2 Construction of Radiology & Medical Laboratory complex (Lot2):

This project is aimed at promoting efficiency in both Radiological and Laboratory services.

2.3 Construction of Central Sterile Supply Department (Lot3):

This project is aimed at improving patient safety by decreasing the risk of contamination of hospital equipment and supplies to zero level. It involves construction of modern CSSD with optimized logistic flow of instruments, equipment and staff in a seamless and sterile manner. The site for this project is within the former NITEL building compound.

2.4 Construction of Accident& Emergency (A&E) block (Lot4):

It is a known fact that accident victims and patients being brought to the hospital are usually referred elsewhere due to lack of bed-space, this particular project would address such challenges.

2.5 General Landscaping (Hard& soft landscaping) at both former NITEL building and the main hospital premises (Lot5):

The purpose of this project is to have a serene environment, which makes the environment very friendly.

2.6 Procurement, Supply& Installation of ICU Equipment (Lot6):

This project involves the procurement, supply & installation of ICU equipment at BDTH aimed at enhancing life support services to patients in critical condition.

2.7 Renovation of SCBU Delivery Suite (Lot7):

This project involves expansion, upgrading and renovation of the existing Labour room (Delivery suit) located adjacent the existing SCBU ward, and the gynecology ward in the hospital.

2.8 Procurement and Installation of Obstetrics & Gynecology Equipment (Lot8):

This project involves the installation of modern medical and non-medical equipment in the upgraded labour room, gynecology ward, and the Obstetrics and gynecology theatre.

**3.0. PRE-QUALIFICATION REQUIREMENTS**

**3.1. Technical Bids**

Interested reputable contractors should submit but not limited to the following:

- a. Certificate of registration/incorporation with the Corporate Affairs Commission (CAC)

- b. Evidence of current registration with The Kaduna State Public Procurement Authority.
- c. Company Audited Account for three years (2017,2018,2019)
- d. Evidence of current Tax Clearance Certificates for three years 2017,2018,2019
- e. Evidence of current registration of Business premises with the Kaduna State Ministry of Business Innovation and Technology.
- f. Technical experience and qualifications of key personnel with evidence of registration with appropriate professional bodies.
- g. Evidence of similar verifiable projects successfully executed/completed/on-going with attached copies of award letters, payment and completion certificates.
- h. Equipment and Technology capacity with evidence of ownership/lease agreement.
- i. Evidence of Financial Capability and Banking Support.
- j. Evidence of VAT registration and remittances.
- k. Evidence of compliance with Industrial Training Fund (ITF).
- l. Evidence of compliance with PENCOM.
- m. Evidence of Bid Security (*if applicable*) in the form of Bank Guarantee or Certified Bank Draft from a reputable Bank in Nigeria.
- n. Any other information that would be relevant.

The documents shall be **arranged** in the order above, **paginated** and **signed** on each page by an authorized representative of the **Bidder**.

### 3.2. Collection of Financial Tender Documents

Interested companies/firms can obtain the Tender Documents, from (14<sup>th</sup> October to 11<sup>th</sup> November, 2020) between the hours 8:00am to 4:00pm, Mondays to Fridays at a non-refundable tender fee of (*refer to the table above*) -payable to Kaduna State Government via Bank Draft, from the address below:

Any submission not accompanied with the draft will NOT be considered;  
The draft must NOT be in the Financial Bid Envelope.

### 4.0. SUBMISSION OF BID DOCUMENTS

- a) Completed Technical and Financial bids are to be submitted in three (3) hard copies each (**Original, Duplicate and Control copies**).
- b) The Technical and Financial bids must be inserted in separate sealed envelopes clearly marked "**Technical Bid**" and "**Financial Bid**."
- c) All the envelopes must bear the name and contact number of Bidder at the rear sides while the '**Project Description**' and '**Lot No.**' clearly marked at the top left-hand corner of the envelopes and addressed to:

- d) The Original and Duplicate copies of the Technical and Financial bids shall be placed in a large outer envelope which shall be dropped into the **Bid Box**.
- e) The Control copies of the Technical and Financial Bid documents shall be marked at the top right-hand side as '**Control Copy**', and dropped in the **Control Box**.
- f) Failure to comply with this requirement of separate and sealed envelopes for Technical and Financial Documents shall lead to disqualification.

- g) The submission shall be made not later than 12:00noon, on the 11<sup>th</sup> November, 2020.

### 5.0. OPENING OF BIDS

The Technical and Financial Bids documents received **shall be opened immediately after the close of receipt of bids** in the presence of the representatives of the Bidders at:

Only technically qualified bids will proceed to the financial evaluation stage.

- b) Evidence of purchase of the bid should be placed in the **Technical Bid Document**.
