PREQUALIFICATION FOR THE PROVISION OF ENGINEERING INFRASTRUCTURE [INCLUDING ROADS, WATER SUPPLY AND POWER SUPPLY] TO THE GREEN AGRO ALLIED INDUSTRIAL ZONE (GAAIZ), ALONG KADUNA-ABUJA EXPRESSWAY, KADUNA STATE - NIGERIA

1. The Kaduna State Government (KDSG) is desirous of providing standard engineering infrastructure comprising roads and associated civil works, water supply and power supply to the Green Agro Allied Industrial Zone [GAAIZ] sited on a **1515 Hectares** land along Kaduna-Abuja Expressway, Chikun LGA, Kaduna State, and has caused drawings and bills of quantities to be produced for this purpose. The most conspicuous landmark of the location is the Olam Poultry Feeds Mill.

2. The KDSG, therefore, hereby invites qualified and competent civil engineering, water supply and power supply [renewable energy] contractors to participate in this prequalification exercise leading to the shortlisting of the contractors who shall bid for the works and the eventual selection of qualified, competent and experienced contractors for the stated works. The Works are to be awarded in 3 major work packages [or Lots] as follows:

Lot No.	WORK PACKAGE
Lot 1	Roads, Bridges, Drainages and Associated Works
Lot 2	Water supply + Distribution
Lot 3	Power supply + Distribution (Grid + Solar)

5. The contractor must possess the requisite financial and technical competence and track record for carrying out the works.

6. SUBMISSION/OPENING OF PREQUALIFICATION SUBMISSIONS

Prequalification Submissions from prospective contractors or consortia of contractors must clearly indicate the following:

- I. Certificate of registration/incorporation with the Corporate Affairs Commission (CAC)
- II. Evidence of current registration with The Kaduna State Public Procurement Authority.
- III. Company Audited Account for three years-(2017, 2018, AND 2019)
- IV. Evidence of current Tax Clearance Certificates for three years (2017, 2018, AND 2019)
- V. Evidence of current registration of Business premises with the Kaduna State Ministry of Business Innovation and Technology.
- VI. Technical experience and qualifications of key personnel with evidence of registration with appropriate professional bodies.
- VII. Evidence of similar verifiable projects successfully executed/completed/on-going with attached copies of award letters, payment and completion certificates.

- VIII. Equipment and Technology capacity with evidence of ownership/lease agreement.
- IX. Evidence of Financial Capability and Banking Support.
- X. Evidence of VAT registration and remittances.
- XI. Evidence of registration with Industrial Training Fund (ITF).
- XII. Evidence of registration with PENCOM.
- XIII. Any other information that would be relevant
- XIV. Draft of N500,000.00 payable to KADUNA STATE GOVERNMENT
