**INVITATION FOR PRE-QUALIFICATION OF CONTRACTS TO TENDER FOR

INTRODUCTION

1. The Kaduna State Government, through the Kaduna State Universal Basic Education Board (SUBEB), has received approval to implement the year 2017 and 2018 UBEC/SUBEB Intervention Projects.

2. In compliance with the Public Procurement Act 2007, the Board wishes to invite interested registered, competent and reputable contractors to submit their pre-qualification document to tender for projects in categories A,B,C,D,E,F and G as follows:

Category A: Construction of New Classrooms, Laboratories, Toilets
Drainage, Rehabilitation of existing facilities and Drilling of Productive Borehole.

Category B: Fabrication of ECCDE Games Village and Installation.

Category C: Supply of Pupils/Teachers Plastic Table and Chairs and
Materials for ECCDE Classrooms.

Category D: Supply of two Seater Pupils Desk/Bench and
Teachers Table/Chair,

Category E: Supply and Installation of Laboratory Fittings and Fixtures.

Category F: Supply of Outdoor Table Tennis and Volley Ball Kits.

Category G: Supply of Orchard and Planting of Wind Breakers
(School Farm)

3. PRE-QUALIFICATION REQUIREMENT:

Interested firms are required to submit documents, including, but not limited to the following:

- i. Evidence of Incorporation with CAC,
- ii. Registration with Kaduna State Public Procurement Authority (KADPPA)
- iii. Company Audited Account for last three years (2016, 2017 and 2018)
- iv. Evidence of Tax Clearance for last three years (2016, 2017 and 2018)
- v. Evidence of Financial Capability and Banking support
- vi. Experience/Technical Qualification of Key Personnel with evidence of professional registration with appropriate professional bodies
- vii. Similar projects executed, or ongoing, and evidence of knowledge of the industry
- viii. Equipment and technology capacity, with evidence of ownership or lease.
- ix. VAT Registration and evidence of past VAT Remittances
- x. Evidence of current Industrial Training Fund (ITF) compliance
- xi. Evidence of current PENCOM compliance
- xii. Current registration of business premises with the Kaduna State Ministry of Business, Innovation and Technology
- xiii. Evidence of current Nigeria Social Insurance Trust Fund ECS Clearance Certificate
- xiv. Evidence of current Interim Registration Report (IRR) from Bureau of Public Procurement
