**BE IT ENACTED** by the House of Assembly of Kaduna State as Enactment follows:

- 1. This Law may be cited as the Kaduna State Registration of Short tittle Business Premises Law, 2019.
- 3. In this, Law unless the context otherwise requires;

**"Business"** includes any trade, industry or profession and any occupation carried on for profit but does not include farming, except such types or classes of farming as the Registrar may specify as being registrable as a business, having regard to the nature, scale and presumed income of such farming business;

**"Business Name"** means the name or style under which any business is carried on whether in partnership or otherwise;

**"Business Premises"** means the premises on which any business is carried on whether situated within or without a building or other structure and whether fenced or unfenced;

**"Existing Business"** means any business existing in the State prior to the date of commencement of this Law;

"**Commissioner**" means Commissioner for the Ministry of Commerce, Industry and Tourism;

"Governor" means the Governor of Kaduna State;

Interpretation

**"Ministry"** means Ministry of Commerce, Industry and Tourism;

**"Permanent Secretary"** means the Permanent Secretary, Ministry of Commerce, Industry and Tourism;

**"Prescribed Fees"** means fees prescribed in the Third Schedule to this Law,

**"Registrar"** means the Registrar of Business Premises designated in accordance with Section 4 of this Law.

"State" means Kaduna State of Nigeria.

- (1) There shall be in the State a Business Premises Registry with a Head Office at the Ministry of Commerce, Industry and Tourism, Kaduna and field offices at such places as the Governor may from time to time direct.
  - (2) There shall be three Zonal Offices in each of the senatorial zones at Kaduna, Zaria and Kafanchan and the Head Office shall serve as the central zonal office.
  - (3) The business Premises Registry shall be headed by a Registrar who shall be the Director of Commerce and Industrial Development in the Ministry.
  - (4) The Registrar shall be assisted in the zonal offices by Assistant Registrars who shall be the zonal Commercial Officers.
- (1) There shall be registered in the manner prescribed by this Law the premises on which every company, firm or individual is carrying on any business in the State.
- Business Premises of Companies, Firms and Individuals to be Registered
- (2) Where a company, firm or individual whose business premises are required to be registered under this Law;
  - (a) changes its business name after it has been registered, or
  - (b) changes its business name after the date of commencement of this Law but before the business premises have been registered, such company, firm or individual shall;

- (i) in the case of (a) above, notify the Registrar of the change of name for alteration in the register; and
- (ii) in the case of (b) above, register its business premises under the business name.
- (3)Where a company, firm or individual changes its business premises after it has been registered under this Law, the company, firm or individual shall notify the Registrar in writing of the change and the Registrar shall alter the register accordingly.
- (1)Every company, firm or individual whose business premises are required to be registered under this Law shall furnish by sending through registered post or by delivering to the registrar at the three zonal offices statement in writing containing particulars mentioned in the Schedule to this Law.
  - (2) Where a business is carried on in two or more different premises, each premises on which the business is carried on shall be registered in accordance with this Law.
- 7. The statement required under Section 6 of this Law shall be signing of Statements signed:
  - (a) in the case of an individual, by him;

- (b) in the case of a company either by a Director, Secretary, manager or Principal Representative thereof; and
- (C) in the case of a firm either by all the individuals who are partners, or by a Director, the Secretary or the Principal Representative, as the case may be, of each company which is a partner, or by an individual who is a partner; and
- in any case under paragraph (b) or (c) above the (d) signature shall be verified by the signatory upon a declaration made by him in accordance with this Law.
- 8. An application under this Law shall be made:

- (a) in the case of an existing business, within twenty eight days from the date of commencement of this Law; and
- (b) in any other case, within twenty one days of the commencement of the business.
- 9. The Registrar may on application being made to him in that behalf extend the time for registration if he is satisfied that there are grounds in the application to justify such extension.
- 10. Whenever a change is made or occurs in any of the particulars registered in respect of any company, firm or individual, the person or persons authorised by Section 7 to sign statements of particulars required by this Law to be registered in respect of the company, firm or individual shall within fourteen (14) days after the occurrence of such change, furnish by sending through post or delivering to the Registrar a statement in writing as in Form C of the First Schedule to this Law, specifying the nature and the date of the change, the statement shall be signed by the required signatories and, where necessary, verified in like manner as in Section 7.
- 11. (1) The Registrar may on application made in Form C of the First Schedule to this Law, and upon the payment of the prescribed fees by a company, firm or individual, correct any error in any particulars registered by him under this Law; such application shall be signed and where necessary verified in like manner as the statement required on registration.
  - (2) Where the Registrar refuses an application made under sub-section (1) he shall within fourteen (14) days of the receipt of such application, in writing notify the company, firm or individual of such refusal.
  - (3) Any person aggrieved by the refusal of the registrar to correct any error may within fourteen (14) days from the receipt of the notification of such refusal, appeal to the Commissioner in writing against the refusal and the Commissioner's decision on the matter shall be final.
- 12. (1) On receiving a statement made in pursuance of section 6 in relation to any business premises and on payment by the applicant of the fees prescribed in the Third Schedule, the Registrar shall file the said statement and shall send by post or deliver to the company, firm or

individual furnishing such statement, a certificate in respect of those premises duly signed by him.

- (2) The certificate shall be in the form prescribed in the Second Schedule.
- (3) A duplicate or counterpart of a certificate issued under sub-section (1) shall be preserved in the office of the Registrar.
- (4) The Registrar may upon the request in writing by any person and upon the payment of the prescribed fees, issue:
  - (a) a certified copy of a certificate of registration the original of which had been issued to such a person; or
  - (b) a certified copy of any application for registration of business premises made by such person.
- (5) The certificate referred to in sub-section (1) of this section or a certified copy thereof shall be kept or exhibited in a conspicuous position at the business premises of the company firm individual place of residence.
- 13. A certificate issued in accordance with this Law shall be prima facie evidence that the business premises to which it relates are duly registered under this Law.
- 14. (1) The Registrar shall keep a register of all business premises registered under this Law.
  - (2) The register shall contain the date of registration, the description and address of the business premises, the name of the company, firm or individual whose business is carried on by the company, firm or individual on those premises.
- 15. (1) If any company, firm or individual whose business premises are registered under this Law:
  - (a) ceases to carry out business; or

# (b) ceases to carry on business on the registered premises:

it shall be the duty of the person who may sign a statement under Section 7 or, where he is dead, his personal representative, within one month after ceased to carry out business or ceases to carry on business on the registered premises, as the case may be, to send by post or deliver to the registrar a notice, as in Form D of the First Schedule to this Law, of the cessation of business, or as the case may be of the cessation of business on the registered premises and the address of the new business premises.

- (2) Where the Registrar is satisfied that a company, firm or individual:
  - (a) has ceased to carry on business; or
  - (b) has ceased to carry on business on the registered business premises,

he shall in the case of paragraph (a) remove the name of the company, firm or individual from the register and in the case of paragraph (b) substitute new business for the registered premises.

- 16. (1) Any person may, at all reasonable times inspect the register of documents filed by Registrar on payment to the Registrar of the prescribed fee.
  - (2) The Registrar shall give a certified copy of an entry in the register or of any field document, other than a certificate, to any person applying thereof on paying the prescribed fee.
  - (3) A certified copy of the certificate or any entry in the register or of any field document shall in all legal proceedings whether civil or criminal be received in evidence without further or other proof.
- 17. The Registrar may require any person to furnish him with such particulars as it appears necessary for the purpose of this Law or for the purpose of ascertaining whether any business premises registrable under this Law are registered, and if he is satisfied from any enquiries that a registrable business premises

has not been registered, he shall proceed to require the premises to be registered in the manner provided by this Law.

- 18. (1)The Commissioner may designate such persons in the Ministry to be inspectors for the purpose of this Law.
  - (2) It shall be the duty of an Inspector, within his area of operation:
    - (a) to visit every registered business premises to ensure that the provisions of this Law are being complied with and to report to the Registrar any contravention or disregard thereof;
    - (b) to ascertain whether any business premises registrable under this Law are not registered and report to the Registrar the existence of such premises and the fact that they have not been registered;
    - (c) to carry out such other duties as the registrar or the Commissioner may assign to him.
- 19. An Inspector may at all reasonable times during the hours of 7 o'clock in the morning and 6 o'clock in the evening enter upon any business premises in the course of the performance of his duties under this Law.
  - (1)An Inspector shall at all times in the course of his lawful duties carry his Identity Card.
    - (2) The production by the Inspector of his Identity Card shall for all purposes be sufficient evidence of the authority of the Inspector.
- 21. (1)If any company, firm or individual whose business (a) premises are required to be registered under this Law fails or neglects to register such premises in the manner and within the time specified by this Law, the company or every partner in the firm or individual as the case may be, shall be guilty of an offence and liable on conviction to a fine of not less than Twenty thousand Naira (N20,000.00) and thereafter shall be liable to a fine of not less than one thousand Naira (N1,000.00) for every day that

the default continues until the premises are registered.

- (b) if any person required by the Registrar to furnish any particulars under section 17 refuses or fails to furnish those particulars or to furnish them within the time or in the manner specified by the registrar, he shall be liable on conviction to a fine of Two Thousand Naira. (₦2,000.00).
- (c) if any company, firm or individual fails or neglects to notify the registrar of:
  - (i) a cessation to carry on business; or
  - a cessation to carry on business on any premises, every person liable under section 15 to notify the registrar of such cessation shall be guilty on conviction to a fine of Two Thousand Naira (N2,000.00).
- (d) if any statement required to be furnished under this Law contains any matter which is false to the knowledge of any person signing it, that person shall be guilty of an offence and liable on conviction to a fine of Fifty Thousand Naira (\#50,000.00) or imprisonment for three (3) months or both.
- (2) Any person who with intent to defraud, alters, erases or mutilates a certificate issued under this Law shall be guilty of an offence and liable on conviction to a fine of not less than One Hundred Thousand Naira (₦100,000.00) or imprisonment for six (6) months or both.
- (3) Any person who impersonates the holder of a certificate issued under this Law shall be guilty of an offence and liable on conviction to a fine of not less than Two Hundred Thousand Naira (₦200,000.00) or imprisonment for six (6) month or both.
- (4) The court convicting any company, firm or individual under this section, may in addition to any penalty, which it is empowered to impose, order the company, firm or individual to do, or to refrain from doing, anything under

this Law, which he has failed, refused, neglected to do and/or has persisted in doing, in contravention of any provisions of this Law.

- 22. The Commissioner may make regulation prescribing all matters Regulations which by this Law are required or authorised to be prescribed including fees for registration under this Law or which are necessary or convenient for giving effect to the provisions of this Law
- 23. Unless any regulations are made under section 22 prescribing otherwise, there shall be paid annually for the registration or renewal of registration, of business premises registrable under this Law and classified therein the fees set out in the Third Schedule.

Fees set out in the Third Schedule

- 24. Any Court of competent jurisdiction in the State shall try the Jurisdiction offender and impose such fine and imprisonment as provided in this Law.
- 25. The Kaduna State Registration of Business premises cap 129 Repeal Laws of Kaduna State 1991 as amended is hereby repealed.
