REQUEST FOR EXPRESSION OF INTEREST (REOI)

1. BACKGROUND

The Kaduna State Government (KDSG) intends to provide standard engineering infrastructure including Roads, Water and Power Supply, among others, in the Kaduna Millennium City to fully service all the plots there and promote their functional development as part of the KDSG's overall State Development Plan.

In pursuit of the above, the KDSG wishes to partner with a private sector investor or a consortium of investors with the requisite technical and financial resources to provide the required infrastructure, maintain it over the tenor of the partnership and recoup their investment from relevant development levies chargeable to owners or subscribers to the plots as derivable from the project business plan.

Accordingly, KDSG hereby invites interested and capable investors to submit Expressions of Interest (EOI) for the Planning, Final Engineering Design, Financing, Construction and Maintenance (within the partnership tenor) of the proposed infrastructure.

2. SUBMISSION /OPENING OF EXPRESSIONS OF INTEREST (EOI)

The Expressions of Interest (EOIs) from prospective investors or consortia of investors must include the following:

- i. Detailed Profile of the company (in the case of a consortium each member company of the consortium) and evidence of registration
- ii. Evidence of partnership in the case of a consortium;
- iii. Evidence of track record in executing similar projects
- iv. Tax Clearance Certificates for 2015, 2016, 2017 of the company or each of the companies in the case of a consortium
- v. Audited Accounts for the last three years (2015, 2016, 2017) of the company or each of the companies in the case of a consortium
- vi. Evidence of Source(s) of funding for the project

3. FURTHER INFORMATION

The Expression of Interest must be submitted in six (6) copies in a sealed envelope clearly marked '**EXPRESSION OF INTEREST FOR THE PROVISION OF ENGINEERING INFRASTRUCTURE – ROADS, WATER AND POWER SUPPLY TO THE KADUNA MILLENNIUM CITY, CHIKUN LGA, KADUNA STATE – NIGERIA**'
