1.0 SCOPE OF WORKS

2.0 PREQUALIFICATION CRITERIA

- i. Certificate of registration with the Corporate Affairs Commission (for corporate entities)
- ii. Evidence of Registration with The Kaduna State Public Procurement Authority (former Kaduna State Tenders Board)
- iii. Evidence of Current Registration of Business premises with Kaduna State Ministry of Commerce & Industry;
- iv. Company Audited Accounts for 2014, 2015 & 2016.
- v. Evidence of current Tax Clearance Certificates for 2014, 2015 and 2016.
- vi. Evidence of VAT Registration and Remittance.
- vii. Evidence of similar jobs executed (complete/current) in the last 5 years (Attach copies of Award letters, Interim Payment Certificates/Practical Completion/Certificate of making good defects.
- viii. Evidence of Technical Key Personnel in your employment (provide their qualifications and professional registration with appropriate professional bodies including certification as Electrical Installation Contractor by NEMSA).
- ix. Evidence of Equipment and Technology available for the works with evidence of ownership or hire.
- x. Evidence of compliance with ITF.

- xi. Evidence of compliance with PENCOM.
- xii. Verifiable evidence of financial capability and Banking Support.
- xiii. Evidence of Payment of N 50,000.00 made payable to Kaduna State Government for each Lot.
- xiv. Any other information that would be relevant.

Please note that the documents listed above shall be <u>arranged</u> in this particular order, <u>paginated</u> and <u>signed</u> on each page by an authorized representative of the company.

3.0 COLLECTION OF TENDER DOCUMENTS:

4.0 SUBMISSION OF TENDER DOCUMENTS:

- The Prequalification/Tender shall be submitted in **five (5) copies** fully paginated and signed; original and 5 copies each.
- The Originals of the Prequalification/Tender shall be sealed in an envelope and indicated 'Original'.
- Three Copies of prequalification document (Technical Bids) together with completed bidding documents (Financial Bid) with other supporting documents shall be sealed in a second separate envelope marked "Technical" and "Financial" respectively.
- Two of the envelopes shall be sealed in a bigger outer envelope marked with appropriated project title. These shall be dropped into the Tender Box provided by the Ministry as usual.
- The last set of copies of the Prequalification and Tender documents shall be so sealed in an envelope duly marked as herein stated above but in addition shall have 'Control Bids' at the same right corner; but this shall be dropped into **Tender Control Box (TCB**) at the same place and time with the other documents.
- Each envelope should be clearly marked on the right top corner and title, while the company name and address should be written on the back of the envelope. All the envelopes shall be addressed to:
