BE IT ENACTED by the House of Assembly of Kaduna State as follows:

- Commencement
- The Accountant General of Kaduna State of Nigeria, may on the 3. Expenditure of warrant of the Commissioner of Finance, Kaduna State issue from the Consolidated Revenue Fund of Kaduna State during the year ending the Thirty First day of December, 2025 any sum not exceeding in whole the sum of Seven Hundred and Ninety Billion, Four Hundred and Thirty Nine Million,

Five Hundred and Eighty Thousand, Eighty Three Naira,

(2790,439,580,083.16) from the Consolidated Revenue Fund

Herein.

The sum mentioned in Section 3 of this Law shall be appropriated for the purpose of and in the manner expressed in the Schedule.
