### REQUEST FOR EXPRESSION OF INTEREST IN THE SUPERVISION OF CONSTRUCTION OF ROADS AND BRIDGES UNDER THE URBAN RENEWAL PROJECTS IN KADUNA STATE

#### 1.0 INTRODUCTION/BACKGROUND FOR THE ASSIGNMENT

The Kaduna State Government has made provisions in the 2020 Appropriation Law to deliver good and qualitative roads that will help enhance socio-economic activities within the State.

In compliance with the provisions of the Kaduna State Public Procurement Law 2016, the Ministry of Public Works and Infrastructure, on behalf of the Kaduna State Government, hereby invites interested, eligible and competent Civil Engineering Consultants to indicate their interest in the Supervision of the construction of Roads and Bridges under the Urban Renewal Projects in the State.

#### 2.0 SCOPE/DESCRIPTION OF SERVICES

The Consultant shall exercise all reasonable professional skill, care and diligence in the supervision of the underlisted works in accordance with the contract specifications, to ensure effective management from commencement to successful and timely delivery:

1	Completion of Dualized Umaru Musa Yar'adua Way to Eastern Bye-pass
2	Dualization of Rabah Road by Arewa House to Nnamdi Azikwe Bye-pass including a Fly-over
3	Dualization of Yakubu Gowon Way - Barau Dikko Teaching Hospital - Waff Road , including an underpass at Leventis Roundabout
4	Construction of FRCN Road (Opposite FGC) Malali to College Road by Legislative Quarters, U/Dosa
5	Expansion of Kabala Costain to Aliyu Makama Road Barnawa complete with a 230m bridge
6	Dualization and Junction Improvement of existing Race Course Road from Independence Way leading to Tafawa Balewa Way
7	Dualization of existing Tafawa Balewa Way
8	Dualization of Nnamdi Azikiwe to Rigasa Train Station Link Road , including underpass
9	Rehabilitation and expansion of Swimming Pool Road from Police Roundabout
10	Dualization of existing Rabah Road (From Arewa House Junction to Waterboard
11	Rehabilitation and expansion of Road from Govt House Roundabout to Nnamdi Azikiwe Bye-pass via Gamagira Road (Ung/Sanusi)
12	Construction of Urban Shelter Road (Umaru Yar'adua Way) to Patrick Yakowa Way
13	Dualization and Expansion of Dutsenma Road to Poly Road via Shema Petroleum
14	Dualization of Poly Road from Govt House Roundabout to Dutsenma Road via Kasuwan Barci Roundabout
15	Rehabilitation and Expansion of Shehu Laminu Road U/Rimi from Total Filling Station to Bamako Road
16	Completion of Nasarawa - Flour Mill - Nnamdi Azikiwe Way Express Way.

### 3.0 PRE-QUALIFICATION REQUIREMENTS

Interested Consultants should submit relevant documents, including, but not limited to, the following:

- a. Certificate of registration/incorporation with the Corporate Affairs Commission (CAC)
- b. Evidence of Registration with the Kaduna State Public Procurement Authority (PPA).
- c. Company Audited Account for three Years (2017, 2018, 2019)
- d. Evidence of current Tax Clearance Certificates for three years (2017, 2018, 2019)
- e. Evidence of registration of Business Premises with the Kaduna State Ministry of Business, Innovation and Technology.
- f. Technical experience and qualifications of key personnel with evidence of registration with appropriate professional bodies and evidence of valid practice license
- g. Evidence of registration of firm with relevant professional body
- h. Company Profile
- i. Evidence of similar verifiable projects successfully executed/completed/ongoing with attached copies of award letters, payment and completion certificates
- j. Equipment and Technology capacity with evidence of ownership/lease agreement
- k. Evidence of Financial Capability and Banking Support
- l. Evidence of VAT registration and remittances
- m. Evidence of compliance with Industrial Training Fund (ITF)
- n. Evidence of Compliance with PENCOM
- o. Evidence of Bid Security (if applicable) in the form of Bank Guarantee or Certified Bank Draft from a reputable Bank in Nigeria
- p. Any other information that would be relevant

*The documents shall be **arranged** in the order above, **paginated** and **signed** on each page by an authorized representative of the bidder.*

### 4.0 SUBMISSION OF BIDS

- a. The EOI Documents are to be submitted in three (3) hard copies each (original, Duplicate and Control copies) inserted in separate sealed envelopes clearly and appropriately marked.
- b. All envelopes must bear the name and Contact number of bidder at the reverse sides while the 'Project Description' and 'Lot No.' clearly marked at the top left-hand corner of the envelopes and addressed to:

- c. The Original and Duplicate copies of the EOI Documents shall be placed in a large outer envelope, which shall be dropped into the **Bid Box**.

- e. Failure to comply with this requirement of separate and sealed envelopes shall lead to disqualification.
- f. The submission shall be made not later than 12:00noon Monday, 9th March 2020
