- III. Evidence of Tax Clearance Certificate for 2016, 2017 and 2018.
- IV. Evidence of Tax Identification Number (TIN).
- V. Current Certificate with registration of Kaduna State Public Procurement Authority.
- VI. Evidence of business registration with Kaduna State Ministry of Commerce and Industry.
- VII. Company Audited Accounts for 2016, 2017 and 2018.
- VIII. Evidence of VAT registration and remittances.
- IX. Evidence of track record in similar projects successfully completed in the last three (3) years.
- X. Any other relevant information that would be helpful in determining the firm's suitability for the project.

1.0- SUBMISSION OF BIDS

Each envelope should be clearly marked on the top right corner, stating the project lot number and title; while company name and address should be written at the back of the envelope. Both envelopes should be sealed (as a set) in a bigger envelope marked as below:
