INVITATION TO TENDER FOR DETAILED REGIONAL GEOLOGICAL/ GEO-PHYSICAL AND GEO-HAZARD INVESTIGATION IN THE STATE

The Kaduna State Government (KDSG) is desirous of carrying out detailed regional Geological/Geo-physical and Geo-hazard investigation of earth tremor sites in Ikara and Jaba Local Government Areas of the State. To this end, the State Government wishes to engage the services of reputable contractors for the study.

In pursuance of the objective of unraveling the cause(s), scale and magnitude of the event, the State Government hereby invites competent and qualified contractors to bid for the works.

PROJECT DESCRIPTION

Lot 1: Yanbarkono Quarters and environs, Ikara Town in Ikara Local Government Area.

Lot 2: Kwoi Town and environs, in Jaba Local Government Area.

SCOPE OF WORK

The scope of the Detailed Regional Geological/Geo-physical and Geo-Hazard investigation should involve the following:-

- i. Detailed desktop review of all available geo-scientific data available in each Lot;
- ii. Acquisition of all topographical and other land use maps (including tenement maps, etcetera);
- iii. Acquisition of satellite imagery data (Quick Bird, Rapid Eye, Landsat, etcetera);
- iv. Acquisition of all Geological, Geo-physical and Geo-hazard datasets;
- v. A detailed collation and interpretation of all available geo-scientific data (geological maps, geo-physical data and geo-hazard data);
- vi. Geophysical survey of 40km2 to establish epicenter (radiometric, aeromagnetic, etc);
- vii. Geological mapping of 40km2 (to establish epicenter); and
- viii. Geo-hazard Survey.
