INVITATION TO BID FOR THE CONSTRUCTION OF DANGOMA – GODOGODO ROAD IN JEMA'A LOCAL GOVERNMENT AREA, KADUNA STATE

1.0 INTRODUCTION/BACKGROUND

The Kaduna State Government, through the Kaduna State Roads Agency (KADRA), intends to construct the road from Dangoma to Godogodo in Jema'a Local Government Area.

In compliance with the provisions of the Kaduna State Public Procurement Law 2016, the Kaduna State Roads Agency (KADRA), on behalf of the Kaduna State Government, hereby invites interested, eligible and competent Contractors to bid for *the construction of the Dangoma to Godogodo road in Jema'a Local Government Area*.

2.0 SCOPE/DESCRIPTION OF PROJECT

The scope of the project will include constructing a 9km road to connect Dangoma and Godogodo towns in Jema'a Local Government.

PRE-QUALIFICATION REQUIREMENTS

- f. Technical experience and qualifications of key personnel with evidence of registration with appropriate professional bodies.
- g. Evidence of similar verifiable projects successfully executed/completed/on-going with attached copies of award letters, payment and completion certificates.
- h. Equipment and Technology capacity with evidence of ownership/lease agreement.
- i. Evidence of Financial Capability and Banking Support.
- j. Evidence of VAT registration and remittances.
- k. Evidence of compliance with Industrial Training Fund (ITF).
- I. Evidence of Compliance with PENCOM.
- m. Evidence of Bid Security (if applicable) in the form of Bank Guarantee or Certified Bank Draft from a reputable Bank in Nigeria.
- n. Any other information that would be relevant.

The documents shall be <u>arranged</u> in the order above, <u>paginated</u> and <u>signed</u> on each page by an authorized representative of the Bidder.
