INVITATION TO TENDER FOR DETAILED GEOLOGICAL/ GEO-PHYSICAL AND GEO-CHEMICAL SURVEY OF ONE MINERAL DEPOSIT (SITE) IN THE STATE

The Kaduna State Government (KDSG) is carrying out a detailed Geological/ Geophysical and Geochemical Survey of one (1) Mineral site of the State. In line with the objective of harnessing the Solid Minerals potentials of the State, the State Government, through the Ministry of Environment and Natural Resources, invites competent and qualified contractors to bid for the survey.

PROJECT DESCRIPTION

Detailed Geological, Geophysical and Geochemical survey of one (1) mineral site in the State - One (1) LOT:

i. Site One (1) – Lot 1 (One).

SCOPE OF WORK

The scope of the Detailed Regional Geological/Geo-physical and Geo-Chemical Survey should involve the following:

- i. Detailed desktop review of all available geoscientific data available in each Lot.
- ii. Acquisition of all topographical and other land use maps (including tenement maps, etcetera).
- iii. Acquisition of satellite imagery data (Quick Bird, Rapid Eye, Landsat, etcetera).
- iv. Acquisition of all Geological, Geophysical, and Geochemical datasets.
- v. A detailed collation and interpretation of all available geoscientific data (geological maps, geophysical data, and geochemical data).
- vi. Geophysical survey of at least 4km² (radiometric, aeromagnetic, etcetera).
- vii. Geological mapping of at least 4km².
- viii. Geochemical Survey.
- $ix. \quad Detailed \, Geological \, investigation \, of \, each \, site \, for \, mineral \, occurrence.$
- x. Topographic Survey.
- xi. Core drilling.

- xii. Evidence of Registration with National Pension Commission.
- xiii. Evidence of Registration with Financial Reporting Council of Nigeria.
- xiv. Evidence of ITF Employers/Registration.

- xv. The company/firm must be registered with the Council of Mining Engineers & Geoscientists, COMEG.
- xvi. The company/firm's Chief Executive must be a registered member of the Council of Mining Engineers & Geoscientists, COMEG, Nigerian Mining and Geosciences Society, and NMGS.
- xvii. Evidence of other similar verifiable projects successfully executed/completed within the last five (5) years.
- xviii. Any other relevant information that would help determine the Firm's suitability for the works.
