- Auditors report for the last three years (2014, 2015 and 2016).
- Tax Clearance Certificate for three years (2014, 2015 and 2016).
- Current business premises registration with the Ministry of Commerce.
- Evidence of Compliance with PENCOT.
- VAT registration and Evidence of remittance.
- List of professionals with professional Qualifications and registration.
- Previous similar works executed within the last 3 years with evidences of Awards and Completion and/or Certificates of payments.
- Any other Documents that may be necessary to pre-qualify the bidder.

The documents shall be *arranged* in this particular order, *paginated* and *signed* on each page by an authorized representative of the company.
