2. SCOPE OF WORK

The scope of the work shall cover rehabilitation/extension of Pipeline network in 8 District offices and as well as rehabilitation/retrofitting of 3 Water Works (including the Power Generating Sets).

3. PRE- QUALIFICATION CRITERIA

Interested Corporate firms should submit copies of the following mandatory documents:

- a. Certificate of Registration/Incorporation with Corporate Affairs Commission (CAC)
- b. Evidence of Current tax clearance certificate for the last three (3) years (2014, 2015 and 2016)
- c. Evidence of Registration with COREN and Practicing License
- d. Current Registration of Business Premises with the Kaduna State Ministry of Commerce, Industry and Tourism.
- e. Certificate of Registration as a Water Service Provider in the Ministry of Water Resources.
- f. Current Certificate of Registration with the Kaduna State Public Procurement Authority.
- g. Company Audited account for three years (2014, 2015 and 2016).
- h. 2.5% bid Security from a reputable Bank in Nigeria.
- i. Verifiable list of similar jobs successfully executed within the last three years, including letter(s) of award, project cost, job completion certificates and contact addresses of the clients.
- j. Verifiable list of qualified relevant staff for the job with evidence of registration with their respective professional bodies.
- k. VAT registration and evidence of past VAT remittance at lease in the last three years etc.
- l. Any other relevant information that would be helpful in determining the firm's capability to execute the works.

Completed Technical and Financial Bids are to be submitted in five (5) hard copies, comprising one (1) original and four (4) copies; in two (2) separate sealed envelopes clearly marked "**Technical Bid**" and "**Financial Bid**" and both placed in a third envelop. A soft copy of the submission is also to be made in one disc deposited in the envelope of the original hard copy. All the three envelopes **must** bear the Company name and contact number at the reverse sides while the "**Project Description**" and "**Lot No**" clearly marked at the top left hand corner of the envelopes and addressed to:
