Basic Education: KDSG Spends N142.9bn in 4 Years

he outgoing Commissioner, Ministry of Education, Ja'afaru Sani, has said that the Kaduna state government has expended N142.9 billion on basic education between 2015 and 2018.

Ja'afaru disclosed this in Kaduna in a paper titled, Management and Funding of Basic Education in Kaduna State, at a 2-Day policy retreat on "The State of Basic Education in Kaduna State: Prospects and Challenges", organised by the state's Ministry for Local Government Affairs.

Sani explained that basic education in Kaduna is being funded through counterpart funding from the state, its 23 local government councils, the Universal Basic Education Commission (UBEC) as well as grants from international agencies.

He further explained that out of the N142.9 billion, N3.8 billion was counterpart fund from the state, LGAs and UBEC, accessed between 2015 and 2016 while counterpart fund for 2017 and 2018 amounting to N5.5 billion would be accessed in June.

Also, the sum of N64.9 billion was spent on primary school teachers and 28 billion naira on education personnel.

Sani also said that N9.4 billion was spent on the state school feeding programme in 2016, while N22.5 billion was spent under the ongoing National Home-Grown School Feeding Programme from 2017 to date.

"Also, N8.3 billion external aid was expended on basic education, of which 21.6 million U.S. dollars, equivalent to N6.6 billion came from World Bank under the Global Partnership for Education and Nigerian Partnership for Education Project.

"3.6 million pounds, equivalent to N1.4 billion came from United Kingdom Department for International Development, Teacher Development

Programme, while N254.2 million came from UNICEF," he said.

The outgoing Commissioner described education as a vital instrument for social and economic mobility at the personal level and instrumental for societal and national development.

"It is on this ground that the state government has made basic education free, introduced school feeding, provided school uniforms, recruited qualified teachers and restored the professional pride of the teaching profession.

"We are equally training and improving the capacity of our teachers and improving learning environment by modernising, rebuilding and expanding schools to accommodate the growing number of pupils.

"Not only that, we are constructing teachers' quarters in rural schools and providing school furniture and sanitation services," he added.

Ja'afaru noted the need for effective monitoring of the Local Government Education Authorities and capacity building for basic schoolteachers for improved teaching and learning.

In his remark, Prof. Kabiru Mato, the outgoing Commissioner, Ministry of Local Government Affairs also explained that the retreat was organised to look at issues around basic education and chart a way forward.

According to him, ensuring quality education at basic level will lay the needed solid foundation for sound and functional education for sustainable development of the state

KADSWAC, KEDCO Synergize for Improved Water Supply

The Kaduna State Water Corporation (KADSWAC) has blamed the incessant water scarcity in some parts of the state to inadequate power supply by the Kaduna Electric Company.

The Managing Director of the corporation, Comrade Sanusi Maikude made this known at a meeting with officials of the

electric company in his office following public outcry about the water scarcity in the state.

According to the water corporation, some of the major places affected by the water scarcity are Malali Water Treatment Plant, Kaduna South, Zaria Water Treatment, kafanchan and Ikara Plants. Others are Manchok, Kagoro,

Kwoi and Saminaka Plants.

Comrade Sanusi , who assured that the state government has equipped the corporation with the needed facilities and personnel to supply the state with adequate clean water urged the electric company to supply the needed energy for enhanced water supply.

Responding, an official of the electric company, Engr. Isa Ahmed, who represented his Managing Director, thanked Comrade Sanusi Maikude for drawing the company's attention to the plight of the people and assured that experts would be sent to monitor the affected places with a view to reactivating the obsolete equipment for enhanced power supply.

He explained that regular meetings will continue to hold between the two parties with a view to enhancing power and water supply to citizens.

According to the Chairman, Kauru local government comprises 3 emirates and chiefdoms ie Kauru Emirate, Chawai and Kumana Chiefdoms. Thus, to ensure justice, equity and fairness to the people of the area, projects provided by the council spread across the 3 emirates and chiefdoms.

Some of the projects currently executed by the Local Government Council include the following: construction of primary school at Barwa, RafinIwa, construction of bore holes at all the 11 wards of the area, construction of drainages at Angwan DakiKauru, construction of abattoirs in the emirate and chiefdoms, fencing of Model Primary School Kauru, construction of 2 box culverts at Subunda, construction of bridges at DingiKono, Hoop Kiffin and Kwabaza, renovation of primary schools at Kigum Yelwa, Kigam, Madaci, Kagadama, Nasarawa Kauru and Kabene.

Others are; purchase of office vehicles and furniture, distribution of 300 irrigation pumps, purchase of generator sets to small scale businesses, provision of training and skills acquisition centres as well as poultry farming, purchase of sewing machines, hair dressing equipment, scholarships, youths and women empowerment programmes and assistance to victims of flooding and other disasters.

The Chairman also expressed gratitude to the Writer's Forum for finding him worthy of the award, stressing that it's time to move the council to the next level of development. He pointed out that his administration was able to

accomplish much because of the enabling environment created by the present administration of Kaduna state.

Goma dedicated the award to the management and entire staff of Kauru local government as well as Governor Nasir Ahmad El-Rufa'i for giving him the opportunity, support, cooperation and encouragement to perform credibly and assured the Writers Forum that the award given to him will further engineer him to deliver more on his campaign promises.

MHSSD BUILDS CAPACITY OF SOCIAL **WELFARE OFFICERS & OTHER GBV ACTORS**

ensuring that women, children, persons with disability and all vulnerable groups are protected from forms of violence, Kaduna State Ministry of Human Services and Social Development with support from United Nation Population Fund(UNFPA) has organized a five-day training for Social Welfare officers, gender actors and all stake holders on Gender Based Violence, prevention, mitigation and protection of victims.

Speaking during the training, the Permanent Secretary of the Ministry, Mrs. Umma Ahmad said that the workshop is aimed at establishing strong and coordinated partnership for Gender Based Violence protection programming in Kaduna state and implementation of its M&E as well as strengthening the capacity of GBV actors to stimulate change for the promotion of social justice and participatory governance.

Mrs Ahmad explained that 4.6% of girls in Kaduna state have experienced sexual violence and about 3 in 10 Nigerian women have experienced physical, mental or sexual violence by age fifteen (NDHS 2013). She further said that the Ministry recorded about 800 cases in 2018 which include 157 juvenile cases, 147 reports of domestic violence, 119rape cases, 116 cases Of gender violence, 115 cases of child abuse. These figures, she

said, are alarming which therefore calls for more work and new strategies on GBV issues.

The permanent secretary therefore called on all participants to be committed and build up their capacity to curb GBV in Kaduna state.

Also speaking at the training, the State Lead of UNFPA, Mariama Darboe mentioned that UNFPA target area of intervention is to improve the Gender Based Violence policy environment at national and state levels.

She also explained that the fund works with various partners to provide survivors with medical, reproductive health services and psychosocial care as part of its commitment to rehabilitate women and girls who have been abused, to help them overcome their ordeal.

While explaining legal instruments during the technical session, the Facilitator, Barrister Rebecca Sako-John of Legal Awareness for Nigerian Women highlighted the 1999 Constitution of Nigeria as amended, with particular reference to chapter 2& 4. She further spoke on the Kaduna State Violence Against Persons Prohibition Law, Kaduna State Gender Equity & Social Inclusion Policy, Kaduna Child Welfare and Protection Law and the difference between sex and gender.

On her own part, the United Nation Population Fund (UNFPA) Gender Coordinator, Silvia Opinia said addressing gender issue is important because of the social discrimination and unnatural stereotypes attached to gender. She explained that the key approach in GBV response should be community and survivor centre based while the guiding principles for response are targeted programmes

Silvia elaborated on the consequences attached to survivors/ victims as well as perpetrators of GBV and further expounded the guiding principles in working with survivors stating that confidentiality, safety and security of survivors is essential to avoid exposing them to more risks.

The gender coordinator also dwelt on the need for proper documentation, data and monitoring, reporting, referral

mechanisms and coordination. Pointing out that responding to GBV needs a multi sectoral approach including access to justice. She also opined that it is the key role of gender actors to identify one another's role while MHSSD institutionalise them.

Mr Dennis Onoise of United Nations International Children Education Fund(Unicef) who talked on child protection and consequences of GBV on children pointed out the difference between a child and an adult. He explained that one is responsible

and the other not, independent and dependent, with difference in physical appearance and perception thus, child abuse is an act of commission or omission, neglect, abandonment and violence against children.

The training which took place in Kaduna had participants drawn from line MDAs, civil society or ganisations, non-governmentalorganisations, professional bodies, media, faith based organisations, security agencies and traditional institutions.
