### EXPRESSION OF INTEREST/INVITATION TO PREQUALIFY FOR PROJECTS UNDER 2019 APPROPRIATION

The Kaduna State Government, through the Kaduna State University, intends to execute some Projects under 2019 Appropriation as follows:

#### 1.0 SCOPE OF WORK

In compliance with the provisions of the Kaduna State Public Procurement Law section 35(7) (a-f) and section 44, the University hereby invites reputable, interested and competent Companies to purchase bidding documents and submit pre-qualification documents for the Lot(s) of interest.

The scope of works comprises all items outlined in the bidding documents (Bills of Quantities or Engineering Measurements and Evaluations) for each of the Lots.

#### 2.0 PRE-QUALIFICATION REQUIREMENTS.

##### a. TECHNICAL REQUIREMENTS

Bidders are to provide the following documents:

- Certificate of registration with the Corporate Affairs Commission, CAC
- Evidence of Registration with the Kaduna State Public Procurement Authority.
- Evidence of Current Registration of Business Premises in Kaduna State.
- Company Audited Accounts for 2016, 2017 and 2018.
- Evidence of Tax Clearance Certificates for 2016, 2017 and 2018;
- Evidence of VAT Registration
- Evidence of similar jobs completed/current in the last five years (attach copies of award letters and certificate of practical completion)
- Evidence of key technical personnel (provide evidence of their qualifications and registration with appropriate professional bodies)
- Evidence of equipment and technology available for the works, with evidence of ownership or hire
- Verifiable evidence of financial capability.

The pre-qualification document shall be **arranged** in this particular order, **paginated** and **signed** on each page by an authorized representative of the company

##### Additional information to be provided includes:

- Sworn affidavit disclosing whether or not any officer of **KASU** or **KADPPA** is a former or present director, shareholder or has pecuniary interest in the bidder and confirm that information presented on its bid is **true** and **correct** in all respects;
- A Sworn Affidavit that no partner/ director has been convicted by a court of competent jurisdiction for any criminal offence related

to fraudulent or corrupt practices or criminal misrepresentation or falsification of facts relating to any matter and that all the required documents are **GENUINE** and up to **DATE**

- The large envelope shall be dropped into the **Tender Box**. The last set of copies of the Technical and Financial Bid documents shall be marked in addition at the top right-hand side as '**Control Copy**' and inserted in the '**Control Box**'. These shall be addressed to:
- Failure to comply with this requirement of separate and sealed envelopes for Technical and Financial Documents shall lead to outright disqualification.
- The submission shall be made not later than 9:00am, on Tuesday, 5<sup>th</sup> November 2019.
