The Kaduna State Government seeks to procure Sustainable Air Quality Equipment for the Kaduna State Environmental Protection Authority (KEPA).

Interested, qualified, competent and reputable professionals are hereby invited to submit prequalification, and purchase bids for the procurement of Sustainable Air Quality Equipment.

Scope of Work

The scope of the project entails the Procurement of Sustainable Air Quality Equipment as described in the bid document.

Pre-Qualification Requirement

Bidders are to provide the company profile and the following documents which **MUST** be arranged in this order:

- i. Registration certificate with Corporate Affairs Commission (CAC).
- ii. Current registration with Kaduna State Public Procurement Authority for 2019.
- iii. Current Business Premises Registration for 2019.
- iv. Evidence of Tax Clearance for 2016, 2017 and 2018.
- v. Company Audited Accounts for 2016, 2017 and 2018.
- vi. Evidence of VAT registration and Remittances.
- vii. Evidence of Compliance with PENCOM.
- viii. Evidence of Compliance with Industrial Trust Fund (ITF).
- ix. Evidence of registration with KEPA.
- x. Previous similar works executed (at least three) with evidence of award and completion and/or certificates of payments within the last five (5) years.
- xi. Letter of authorization for KEPA to make enquiry on any/or all the documents submitted.
- xii. Any other document that may be necessary to pre-qualify the bidder.
- xiii. Each prequalification document must be paginated and duly signed by authorized personnel.

Purchase of Bidding Document

BID SUBMISSION/CLOSING OF RECEIPT OF PRE-QUALIFICATION AND BIDDING DOCUMENT

The prequalification (Technical) and Bid document (financial) and other supporting document shall be fully paginated and sealed in 3 (three) separate envelopes. The original prequalification and a copy will be put in the same envelope sealed and marked "Technical"; the original financial Bid and a copy will also be put in another envelop sealed and marked "Financial".

Two of these envelopes shall be placed in an outer bigger envelop and be so marked including the address, telephone numbers of the company at the reverse side. A copy each of the Technical and Financial bid shall both placed in a sealed third envelope and indicated at the top right side in addition to other information – "Control Copy", which shall be dropped in the Tender Control Box (TCB).
