BE IT ENACTED by the House of Assembly of Kaduna State as follows:

Enactment

This Law is cited as the First Supplementary Appropriation Law, 1. Short Title 2018.

This Law comes into operation on the!9. day of 2. Commencement July 2019.

3. The Accountant General of Kaduna State of Nigeria, may on the Expenditure of warrant of the Commissioner of Finance, Kaduna State issue from from the Consolidated the Consolidated Revenue Fund of Kaduna State during the year ending the Thirty First day of December, 2019 any sums not exceeding in whole the sum of Eighty One Billion, Six Hundred and Eighty Two Million Four Hundred and Forty Four Thousand, Two Hundred and Forty Three Naira, Twenty One Kobo Only (N81,682,444,243.21) as specified in the Schedule herein.

4. The sum mentioned in Section 3 of this Law shall be appropriated for the purpose of and in the manner expressed in the Schedule.
